Finance ~ Pam White

- → 3rd quarter expenses by department: the mark is at 75%, the department is under budget on expenses. Quarter expenses YTD is \$14 million and YTD \$41 million. Our budget is \$61.8 million. We are under budget about 8%.
- → 3rd quarter expenses by account:
 - @ 92% in overtime
 - Salaries at 60%
 - @ Operations at 56.82%
 - Total expenses at 66.89%
- Revenue: 9 months into the fiscal year. 75% of receiving revenue. Current quarter is \$15 million, YTD is \$47 million, and our budget is \$62 million. We will be at about \$63 million which is more then what we forecasted.
- Pie Chart: enplaned is up by 1.9% and deplaned is up by 4.3%. Calendar year to date as a whole is 2.4%, air traffic control is down by -3.9%, and Double Eagle is up by 1.2%.
