 - Goal 1: Encourage major airlines to increase frequency of flights to existing markets and start service to new markets. 2 destinations added from Frontier
 - Goal 2: Make the airport more internationally accessible by adding bilingual signage, a new FIS and international flights. International Flights – New Federal Inspection Station: this went out for Bid
 - Goal 3: Investigate and act on ways for Aviation to participate in public transportation initiatives to and from the airport.
 - Goal 4: Support a safe, efficient and innovative airport through smart technology, state of the art ideas and a focus on the overall customer experience.
 - Goal 5: Lead the development of Western Intermodal Transportation Hub by creating an Airport Investment District and buildout of ACE. ACE Economic based jobs.
 - Goal 6: Using P3 Model, nurture and grow intermodal business from both local and out of state companies. General Aviation at ACE and use the P3 model.
 - Goal 7: Develop and execute new marketing efforts to better communicate and engage with our community. Marketing created 2 new positions and working on a transparency project




