- I. Call to Order Lee Truitt, Vice-Chair, 9:01 am
- II. Changes/Additions to Agenda Lee Truitt, Vice-Chair none
- III. Approval of October 15, 2020 Board Meeting Minutes ~ Lee Truitt, Vice-Chair Marie move as circulated, Lee 2=second; approved
- IV. Reports
 - Reports/Updates & Business Development ~ Director Nyika Allen
 - Orion Group announcement last week; EPC proposal approved; will take 122 acres of land, entire ACE, west of Girard; Janet will send out articles
 - Lee Synopsis; group Orion subsidiary of Theia group Inc. New co that is creating a company in satellite manufacturing; federal project infrastructure list; creating constellation of satellites in space to help digitize the earth; backed by multiple governments
 - Marie how will this affect traffic coming in and out of airport?
 - Nyika Yes, we will need to shut down Girard to accommodate the building; will impact traffic
 - Fred Are these eight story structures? Nyika, yes and we will be doing a lot of work to accommodate; working with traffic; potential batch plant for concrete; renting out parking lots for construction workers and items/supplies.



- Marie will it affect with cell phone parking lot; Nyika, yes, it will be relocated
- Deputy Director Richard McCurley (Landside)
 - Update little over year ago airport experienced a major power outage
 - PNM has switched 5 out of 6 switch gears. 6th one on hold for Orion project; starting to certify the remaining 5
 - Project Manage program in early stage; developing a handbook for planning team to formalize project phases; working with WSP
 - Tenant improvement program; tenants able to upload onto sight and implement standardized process; incorporating guidelines (interior structures, building structures
 - Started monthly meeting CIP and review with full team; to provide updates and input; helps define where we can push forward
 - Enterprise asset manager and computerize management systems; working with Macintosh; at about 2/3 mark; in communication 5 airports to determine what they CMMMS use in asset management system; report will be finalized and will review over next few weeks
 - Lee is this a good time for CIP projects considering COVID; RM initially assessed all projects; shift out quite a few projects for upcoming years;, but also ideal time quicker, faster; financially in a good place to move CIP along; moving along some critical projects
- Deputy Director Steven Petty (Airside)
 - Airside Orion touching airfield
 - Security Project coming to completion 1Q21, looking for substantial completion December; will bring us up for 2020
 - Airport COVID point, to ensure compliance; we have purchased facial recognition kiosk temp check stations; last 6 months used Securitas; will save money and time; working out kinks and working out well; at forefront to make sure temp checks are occurring with aviation personnel; keep in line with HIPPA; Steve on POC to ensure security;
 - Operations for Jane taxiway E, slated for construction end Jan 2021 into next year and completed by fall 2021
 - Marie how many positive cases among staff; #5 steve; were those picked up at site or other places; steve all off duty and got from family; reported to state; state did not need to come out due to procedures; in place
 - Lee any trends; steve within last 2 weeks; picking up from other family members or associates; Marie not picking up at airport? Steve not at this point
- Finance ~ Josh Castellano-Gonzalez
 - Everything has ben consistent for a while; had initial uptick of passengers July down 70% from last year, and has been holding there; average is 70% passengers; still maintain 1200 days Cash on hand; good financial polace; cares draw within next week \$2 million; salary expenses;
 - Budget season FY22 document staff working on; meeting with staff mid-December to review documents;
 - Holding steady waiting



- Lee is CARES draw intended to offset revenue losses; josh it does not correlate; will offset price increase with Cares funding, along with RAC with CARES funds; CARES \$ keeps us in good financial position moving forward

- Business Development ~ Lisa Leyva
 - Working of Project Orion
 - Other efforts moving forward; COVID has not impacted
 - Non-aeronautical revenue update; brought advertising concession in house and have completed the media kit and rate sheet; have secured four contracts with folks interested in continuing to advertise in airport; this means we receive 100% vs 50% revenue; assets available to us in airport; hats off to Jonathan for rate sheet development; response has been good UNM, Frank Frost (2 years)
 - Air Service Updates -Fred Air Service airlines consistent point; new activity for holidays; frontier pulled out but in for holidays; out January
 - American dropped their Chicago flight
 - Last month one flight to LA out of Albuquerque; Delta add 2nd in Dec and 3rd for holidays
 - New United Express carrier; Commut Air in December fill shoes for Express Jet
 - Yesterday, 737 max approved
 - Lisa Jet Blue resume red eye December; Allegiant pausing in January; Express Jet out of business = no impact; lee presence in Houston
 - Lee where does Fred compile info; Fred I check each airlines website; noticed lately American shows full schedule for January but anticipate reductions; airliners.net good forum every Tuesday
- Public Relations ~ Jonathan Small
 - Media coverage pitched film kiosk to national industry publications; ACI Centerlines eblast and website; and response Aviation Pros magazine in December issue in print; working on getting NA as a special pros podcast;
 - Gov's most recent changes to public health order; have had to postpone blood drive; art installation; ambassador program, until numbers get better;
 - Art program prior to COVID numbers increasing, we resumed display case and new exhibits; currently, partial preview of upcoming exhibit installed in April (Explora) involved interactive kiosk (part of main Explora location); has interactive projects developed by students; can't have interactive activity; repurposed 1 kiosk that describes upcoming bigger project; installed in the meet and greet area
 - Met with curators with Balloon Museum to show space we are offering up/; when they saw space were excited; they will formulate a plan on their end within couple weeks; currently timeline install of April /May through Dec 2021; Stay tuned; show case unique topic to ABQ, history of Ballooning.
 - Fred saw new sign on Sunport Blvd, refurbished clock in same place; looks great; Jonathan the public has been asking about; retrofit digital clocks; adds nice focal piece to Great Hall; mural Sunport Blvd.; 2nd phase postponed, 50' mural will showcase each letter within the terminal; install date TBD



- Lee clock, the movement is very satisfying to watch
- Marissa re gov's orders, is the Sunport trying to push out folks not traveling for holidays; what does that look like given the high risk and high numbers and people inside; Jonathan not encouraging folks to travel; providing info for folks to travel as safely as possible; focus to make sure we are making it as safe as possible; not promoting; Lisa L, redirected advertising as soon as NM on NYC quarantine list, advertising pulled; article with KRQE yesterday; cognizant thankful for folks keeping operations running (concession workers, custodial); very deliberate in messaging
- Marissa, received email from Allegiant; to watch game on the strip; important to not encourage that for New Mexicans; Lisa L, airline partners pushing out their own messaging; we are not piggybacking off their messaging; we promote Gov's orders in our messaging

 - Lee air med evac flights? Any more segregation; Jesse from large ramp; get radio call precautions/ vs non-precautions; precautions = most remote spot on ramp and segregated; ambulance do park and wait and ensure out as expedient as possible
