 - Wrapping up 2021 goals & developing 2022 goals
 - Meetings on performance measures
 - Projects
 - Announcement 2/15/22 \$85M Renovation Project Post Security Terminal Infrastructures Concessions; TSA checkpoint moved to where Tia Juanitas located; TSA expansion & concessions program; post security expand space by 24%; double que line; 2019 - average under 15 minutes
 - TSA inline baggage on hold until latter calendar year 2024
 - Emergency Power Project; broke ground last week; replacement of emergency generators & install UPS systems



- Power outage yesterday went seamless; one airline cancelled 3 flights due to internal computer system; will meet with them tomorrow
- PC Air Project; replacement units; working with FAA HQ on project to finalize documentation to keep grant moving forward; weekly updates
- Electrical Infrastructure project final stages of recommendations; final document mid-March on recommendations; then review immediate responses to repairs and capital projects
- Landside passenger boarding bridges; meeting with team today and scope design
- Q&A:
 - Jay Do emergency generators keep going thru night; Richard yes; Jay do we have #s throughput? Richard yes we have forecasted out with crowd modeling; TSA checkpoint through 2039; will get team to pull numbers and send to board
 - Anthony Did Board review TSA project feasibility study? Richard - project ongoing 2 years; Anthony – visual aid histogram; view trends; Richard, will get those sent out Marie would like to get financials in future
- Fred -went to NY LaGuardia last month; did same concept we have now
- Reports/Updates ~ Peter Pierotti, Acting Deputy Director
 - Serving as Acting Deputy Director; primary role is to support Richard; oversee activities (Josh/Lisa)
 - LaGuardia incredible renovation; once termed as a 3rd world airport
 - Brent handling legal during this time
- Finance ~ Josh Castellano-Gonzalez
 - Currently in budget process; budget hearing CAO Saturday; went well
 - Working on single audit this year; Moss Adams changes and taking a little longer then usual; heavy lift for department; so far no audit findings Aviation
 - Marie where are we financially sound with percent income, depth, etc.?
 - Josh -Expenses slightly under budget; 4% under budget division; revenue 2% over budget due to rental car % rents higher due to inflationary rates; have more money coming in before 2019; parking has grown to pre-pandemic levels; no Uber/Lyft folks parking at terminal; lot closed Yale / Girard; absorbed some of that market share; Jay does that mean more people are parking at airport? Josh yes; helped us out and other lots near the airport; Jay any plan of anyone buying lot; Josh understanding it was purchased by Mr. Carwash; won't be a parking lot; Marie how many spaces; Josh -not available at this time; Marie if we are anticipating increase, is parking becoming more of a problem of losing couple hundred spots; Josh no, Fast Park fills up during



holidays, (peak time), Sunport/University lot still about 50% full; we close down when it's peak; there are 500 spaces available Sunport/University; airport shuttle leases parking lot at Sheraton across the street; don't anticipate it being a problem; anticipate Uber/Lyft to pick back up and parking will decrease

- Jay to Richard Has there been consideration to take over some of ACE to develop as parking lot; Richard- we have in master plan in sites; e.g. east side parking; FAS may be building parking structure near FIS property near shuttle operations; reclamation for landfill; if expanding for parking; starting to analyze to look at service level of roadways; Jay when was parking garage built; Josh 1989 or 1991; Fred expansion 87-89 built; Jay any requirement or do we do our own engineering analysis to make sure structurally sound; Richard Project now in scope preliminary engineering report; structural analysis, fire suppression, lighting, etc.; parking guidance systems; ongoing ready to change over to design
- Josh working with financial advisor to get base rates to make sure covering costs of commercial roadway; agreements not in place; Richard - we looked at recommended rates (financial analyst); where recovering capital costs and to work with them for fair charge; ongoing and should finish up; want fair amount and working relationship but also recovering our costs
- Operations Overview ~ Jane Lucero In interviews out
 - Richard 3 projects
 - Taxi C moving along 3/14 break ground
 - West terminal ramp completion date 8/18/22; replacement of westside of airport
 - Air cargo expansion; new entrance; cargo facility; slated to complete 12/23/22
- Business Development ~ Lisa Leyva
 - Airline partner updates; experiencing staffing issues; SWA adjusted schedule; BWI? exited this summer; Burbank doing well; AA upguaging air craft; Austin flight; network planner left Allegiant and joined American
 - KRQE morning show Tuesday; spoke about renovations about how to do business are the airport; educating public on different areas; communication plan doing business website; hosting outreach events; NM restaurant Assoc; business bureaus and engage their members to learn more how to do business at airport; engage current concessionaires and reach out to community
 - Media for direct flights
 - Economic projects moving forward; does not include parking lot in ACE; have other plans
 - Power outage PIOs out yesterday
 - American updating aircraft serving us, will increase passenger capacity; from 2-3 times daily to LAX; upguaging E175 to 738?; 126% seats for us; Austin looking good for us; American seeing opportunity to fill gaps; Marie



- would be helpful to see what % of seats are filled; Lisa - when we look at seat capacity we are higher load factor; DOT data lags, 60-90 days out on DOT data; will work on this and include in future reports; staffing challenges pose different scenario;

- Will Do we have rep working on ACE for us
 - Lisa we have a list of commercial realtors available; working with AED (AREA) and have website listing our properties.
 - Orion outcome created high profile project; people are reaching out; good position with ACE; prior to last year, we were in process of recruiting developing/marketing project
 - Working on publishing list of commercial lists of realtors to help with all properties; confident being marketed properly; Jay - have you talked to air force people who want additional space
 - Peter, if we use other professionals we open ourselves up to additional fees; we have contingency for properties not currently in negotiations
- David Ortiz for properties at ACE, is there access to airfield? Lisa yes, we can move fence; abide by FAA rules and regs; have parceled off 20 acres for aeronic use to have access to airfield; David -a secure facility on lease? Lisa yes, David will reach out to Lisa
 - Peter we have looked at hypothetical access to base from that property; number of different opportunities involving DOE and base for consideration; David outgrowing current foot print; will follow-up
