Minutes

- 1. Call to Order/Roll Call Jon Word, Chair Meeting Called to Order at 9:02 a.m.
 - a. The appointment of Dayan Hochman-Vigil to the Board was approved by the City Council on February 5, 2024, replacing William Ferguson
- Changes/Additions to Agenda—Jon asked about Annual Report. He will work on report. Peter to send prior report to him.
- 3. Approval of Board Meeting Minutes (01/18/2024) Approved by consent.
- 4. Director's Reports
 - Employee Development: Held Crucial Conversations successful training
 - Town Hall Meetings highest attendance yet
 - Sunport Operations—generally passenger and operations are increasing.
 - Retail is down with closure of Hudson for construction. Food and Beverage was up in December, but will slow down for next few months.
 - Completed four jet bridges, and will continue work until all complete.

- Cell phone lot relocation likely in October next to Sheraton.
- Monument sign project—no bids received, so looking at options.
- Parking garage work ongoing. Jon remarked how good the new lighting is.
- Solar Canopy project timeline four years.
- Two rehab projects at DEII and studying GA terminal
- Submitted for FAA grant at DEII
- Aviation Department awarded grant of \$3.5 million for in-line baggage systems.
 - Josh Castellano-Gonzales provided finance updates
 - Daniel Jiron provided capacity update—down a bit over last year. Flights up, yet seats down. Destinations up. No concerns. Always a slump in January. Market share about the same. Sun Country starts up in June seasonal service from June to August. Jet Blue returns tonight. SW adding additional frequency to Midway. Fred DeGuio added that American dropped Austin flight. Spirit adds second flight to Vegas. SW plans to increase to more flights by October. American and United adding more flights.
 - Daniel Jiron and Manny Manriquez Will be traveling to promote international air service.
 - Brian Boyd reports on air traffic. Up at Sunport, down at DEII, but increasing.
 Following GA trends. Hope for improvement with new hangars.
 - Gary Gilliard provided Food and Beverage report. Retail is out for bid now. RFP for management of ASCEND program to be issued soon. Discussion of new Alcohol program.
 - Manny Manriquez reported on High Flying Hangars. Mesa Studios contract negotiations concluding.

Board Input:

- Jon Word notes new TSA checkpoint seems to be working well. He wants to develop GA and to address hangar capacity at Sunport. U-Haul would base planes here if there were hangar space. Suggest organizing a committee to do visioning.
- George Slad advised he can't afford to build hangar in ABQ, and that this is a problem nationwide.
 Director McCurley noted that Atlantic has declined to move forward with hangar buildout.
- Fred DeGuio commented on salt removal from walkways

- Jon Ward wants to regroup DEII group.
- Jon Ward notes Cutter has doubled its rates.
